Summary

The 2023 Annual Meeting of the Network of Central and Eastern Labour Law Experts focuses on *the role of* workers' representatives and their effects on the quality of industrial relations. Members of the CEELex Network will present findings of their research on the following topics:

- Participation of elected workers' representatives in workplace cooperation, including information and consultation, grievance handling, just transition, OSH committees;
- Role of workers' representatives in collective bargaining, including legal conditions, election, mandate, outcomes, right to strike;
- Relationship between workers' representatives and trade union(s) and workers' representatives and works' councils including mandate, coordination, challenges and opportunities;
- Impact of recent changes in law and practice concerning elected workers' representatives on the national industrial relation system; and
- Potential for elected workers' representatives to become a collective voice on digital platforms.
