#### Introduction

The Employment and Social Affairs Platform 2 (ESAP 2) is a regional project, funded by the EU and jointly implemented by the Regional Cooperation Council (RCC) and the International Labour Organisation (ILO), over a three-year period, 2019-2022. The objective of ESAP 2 is to assist the six Western Balkan economies (Albania, Bosnia and Herzegovina, Kosovo\*, Montenegro, North Macedonia and Serbia) with labour market and social policy reforms in order to improve employment opportunities and working conditions of citizens in the region.

As part of the ESAP 2 Project, its Component 3: *Western Balkans engagement in EU employment and social policies*, is focusing on activities to provide peer learning opportunities to enhance Western Balkan alignment with the EU acquis in relevant fields (Chapters 2 and 19), European Pillar of Social Rights and preparation for the future use of European Social Fund.

One of the objectives of ESAP 2 project Component 3 is to support Western Balkan government partners in their EU accession path ***through establishment of Regional Network of EU Chapter 19 and Chapter 2 (WB6 Network) negotiators and civil servants dealing with topics related to these chapters in WB economies where negotiation structure still does not exist.*** This WB Network is **an informal network**, and among other goals, is expected to provide peer learning and capacity building activities on topics that will be proposed by the Network and relevant to the EU accession process (employment and social policies), including on the European Social Fund.
