# Employment and Social Affairs Platform Meeting of Ministries of Labour of the Western Balkan Economies

13 - 14 December 2016 Podgorica, Montenegro

#### **Introduction and Objectives**

This event is organized in the framework of the Employment and Social Affairs Platform (ESAP) regional project, which aims to strengthen regional cooperation and institutional capacities of national administrations in the areas of labour market and social policy reform.

Participants in the event will be representatives of Ministries in charge of labour and employment, responsible for their institution's contribution in the development, implementation and monitoring of employment and social policy measures, including initiatives such as the Economic Reform Programmes (ERP) and the Employment and Social Reform Programmes (ESRPs). Additionally, representatives of RCC and ILO, as implementing partners of the project, will participate. An invitation will be extended to representatives of DG Employment, Social Affairs and Inclusion of the European Commission as well as to other partner international organizations.

The aim of the meeting will be to present and discuss with participants key findings of a regional analysis of employment and social policy measures in the Western Balkan economies, share national experiences in developing and implementing labour market measures with a focus on those prioritized in national strategic documents such as the ERP and ESRP, and agree on collaborative steps to enhance the sharing of good experiences and mutual learning.

#### **Background**

The regional project 'Employment and Social Affairs Platform', which began its implementation in March 2016 and will last for 3 years, is a regional project financed by the European Commission and jointly implemented by RCC and ILO in the Western Balkan economies (Albania, Bosnia and Herzegovina, Kosovo\*, Montenegro, Serbia and The Former Yugoslav Republic of Macedonia). The project aims to strengthen regional cooperation and institutional capacities of national administrations, employers' and workers' organizations, enabling them to develop and effectively implement labour market and social policy reforms in their EU accession process.

One of the project goals is to support the processes for preparation, monitoring and follow up of employment and social policies with a focus on the relevant measures in the Economic Reform Programmes (ERPs) and the Employment and Social Reform Programmes (ESRPs). In this context, RCC has commissioned a regional study that will:

- Analyse the major features and identify strengths and weaknesses of the national employment and labour market strategies, including the ESRPs in the economies where these have been developed and the measures prioritised in the ERPs;
- Create a catalogue of recent, current and planned national employment and labour market measures, in particular those referring to active labour market policies and Public Employment Services from which case examples can be developed and around which peer reviews can be organised;
- Summarize the indicators included in the above mentioned strategies and documents;
- Propose lessons learned and recommendations for the design of employment and labour market strategic measures and their implementation, monitoring and evaluation;
- Make a regional comparative overview of the major findings and common recommendations.

Initial findings of this study will be presented and discussed with participants, with a view to agreeing on a set of recommendations for enhancing their impact as well as possible tools that will help strengthen sharing of good practices and relevant knowledge.
