- Healthy, safe and well-adapted work environment


Adequate and sustainable social protection


Further initiatives in the pipeline

Why is the European Pillar of Social Rights important for the Western Balkans?





Roll out of the European Pillar of Social Rights in Western Balkans

- The Western Balkan Ministers in charge of social policy committed in November 2018 to strengthen the social dimenson of Enlargement Policy
- WB Ministers adopted European Pillar of Social Rights as framework for social policy development in their countries





Roll out of the European Pillar of Social Rights in Western Balkans

- Endorsement at WB Balkan Ministerial 2019
- Dedicated periodic reviews and policy action
- Spin Offs and Follow Up actions e.g. on Youth Policy in North Macedonia
- Funding under IPA III
