## Objectives of the Network

- Cooperation and joint action: the Network will facilitate closer cooperation across borders, and develop effective and efficient tools that facilitate the work and support capacity building;
- Mutual learning: peer learning and peer reviews will be organised in different formats such as thematic reviews, seminars or mutual assistance;
- Increasing knowledge: analyses of existing information and small scale research studies to better inform institutional policy making and implementation and encourage innovative approaches to tackling undeclared work.

#### Holistic integrated strategic approach

 a whole government approach joining-up on the level of both strategy and operations the policy fields of labour, tax and social security law, and involving social partners. It uses the full range of *direct* and *indirect* policy measures available to enhance the power of, and trust in, authorities respectively. The objective is to transform undeclared work into declared work in an effective manner.
